

# A Study on Reading Habits of Users in Manonmaniam Sundaranar University, Tirunelveli, Tamil Nadu

**Abstract** – Reading Habit has been a subject of investigation in Librarianship, Journalism, Education, Psychology, Literature and history. Specifically reading habit refers to the settled tendency or practice of people to voluntarily seek reading material and devote time to reading. This article attempts to investigate into the reading habits of university students by studying about their use of university library. Questionnaire is used to investigate the participant's general attitudes towards reading and their reading preferences. The gathered data highlighted what motivates students when they read for leisure and their preferred language of reading materials.

## I. INTRODUCTION

In the age of modern living mastery of printed word is essential. Documents furnish keys to understanding one's self and they provide opportunity for improving the art of human relationships. Reading has been the key subject in the curriculum for young children for centuries, and the subject for considerable research activity and controversy. It is a basic tool of education and one of the powerful and lasting influence in the promotion of one's personal development in particular and social progress in general. David H. Russel and Henry Fea defined reading as "the act of identifying the symbol and obtaining meaning from the identified symbol". A good reading habit is an important tool for the development of personalities and mental capacities. Library is a centre of knowledge and temple of learning established to meet the information needs of its readers. The readers are the key person in any information system. In a library and

information centre, the essential components are documents, readers and librarians. It is a common complaint that the information users often neglect the general readers and their information needs. It is the responsibility of the Librarians to make available the relevant information to the reader. The present article aims to study the reading habit of the students studying in Manonmaniam Sundaranar University, Tirunelveli by analyzing the use of reading habits of the students.

## II. MANONMANIAM SUNDARANAR UNIVERSITY : PROFILE

Manonmaniam Sunaranar University (MSU), Tirunelveli was established on 7th September, 1990, by the Government of Tamil Nadu as a Teaching cum affiliating University. The University is named after the Tamil poet laureate Prof.P.Sundaram Pillai (1855-1897) who is the author of the famous verse drama MANONMANIAM. The University caters to the needs of the three southern districts of Tamil Nadu viz. Tirunelveli, Tuticorin and Kanyakumari. The University is located in a campus of 550 acres at Abishekapatti (on Tirunelveli Tenkasi Road) at a distance of 8 kilometers from Tirunelveli Junction. Manonmaniam Sunaranar University is accredited by NAAC with B++ grade equivalent to 5 star status with a mission in pursuit of Excellence by providing quality education. There are 24 academic departments in the University. The University offers Post-Graduate, M.Phil. and Ph.D. programmes (Full time and Part time). Manonmaniam Sunaranar University is the first to offer Choice-Based Credit System.

**A. University Library**

The Library is located in a double storied building constructed in the front part of the University campus. It is a quite spacious place and provides separate space for journal users and book users. The users of the library are facilitated with adequate number of furniture to ensure better reading. Separate rooms are provided to carry out technical works and circulating books. A separate research section with research reports is available to encourage research activities. With the help of INFLIBNET center, Ahmadabad a LAN (Local Area Network) is established for the purpose of Library automation, online bibliographical services and the Internet browsing. The University Library has rich collection of books and journals on a wide range of subjects. The quality and quantity of the collection and the information resources have earned all – round appreciation from readers.

**III. OBJECTIVE OF THE STUDY**

The primary goal of the study is to examine the reading habits of students in the University Students. More specifically the study is aimed at the following:

1. To find out reading materials like read books, periodicals, newspapers etc.
2. To identify the actual strengths and weakness of library resources and services.
3. To find out how students spend their leisure time and whether reading constituted as one of their very important activities.
4. To assess the use of library facilities by the readers to ascertain reader satisfaction.

**IV. METHODOLOGY**

For data collection, primary questionnaire method was used. In order to corroborate the findings arrived at from the questionnaire was also used on a selective basis.

Data was collected from Manonmaniam Sundaranar University. 175 questionnaires were distributed among the students in M. Phil and Post Graduate Engineering boys and girls and also from M.B.A students. A sampling of 175 students consisting of 75 boys and 100 girls has been selected on the basis of stratified random sampling method. To collect first hand information a structured, close ended mailed questionnaire has been used.

To give equal representation student have been selected both from under M.Phil and Post Graduate Engineering boys and girls and also from M.B.A students as given below:

**A. Limitations of the Study**

It is evident from table II that the majority of the respondents visit library for the purpose of referring to general books. Next, students visit library to refer to technical books. The third categories of students come to library to refer to journals connected with their subjects, science books are very rarely by the engineering students.

Out of 175 student respondents only 16 students have stated that they go to library mainly to read news papers.

The purpose of visits by the reader will not serve any purpose unless it is clear as to how long do they stay in the library. Their responses in this regard are given in table III.

Table III shows that hardly 1% of the respondents stay in the library for more than three hours. On enquiry, it is reliably learned that few M.Phil students stay in the library for more than three hours during the last semester and concentrate on the preparation of their final project. The

majorities of the M.Phil students visit the library during library hours and stays for 50 to 60 minutes and push off to next class during next period.

Regarding the attitude of the library staff, different type of users hold different views.

Out of the respondents of 175 students 140 persons have stated that the library staff are friendly and only about 35

respondents stated that library staff are harsh, strict and are not friendly.

## VI. FINDINGS AND SUGGESTIONS

The University library is equipped with about 98,476 books and about 193 National, International level journals.

The studies on library readers identify how many people used the library and how many books have been borrowed and the purpose of their visit. The study reveals that about 88 respondents visited library to refer to general books. About 16 respondents have utilized the library to study news papers. The study also revealed that majority of the visitors stay in the library for less than an hour. Research scholars use the library for more than 2 to 3 hours for preparing for their dissertation. Students also felt that the numbers of library cards given are not enough so it is suggested to give more cards. Library period should be included in the timetable so as to increase the reading habits among students.
